## International Congress on Advances in Nuclear Power Plants (ICAPP)

The 2004 International Congress on Advances in Nuclear Power Plants (ICAPP '04) will be held during June 13-17 in Pittsburgh, PA at the 2004 ANS Annual Meeting. ICAPP is the premier international conference on nuclear power plants and is jointly sponsored by five of the world's major nuclear societies – the American Nuclear Society (ANS) <a href="http://www.ans.org">http://www.ans.org</a>, Sociedad Nuclear Española (SNE) <a href="http://www.sne.es/">http://www.sne.es/</a>, Société Française d'Energie Nucléaire (SFEN) <a href="http://www.sfen.org/">http://www.sfen.org/</a>, the Atomic Energy Society of Japan (AESJ)

Nuclear Society (KNS) http://www.nuclear.or.kr/e introduce.php.

The Operations and Power Division of ANS is the primary sponsor of the Congress. ICAPP is an annual event that is held bi-annually in conjunction with the ANS Annual Meetings and rotates in off-US years between Europe and Asia. ICAPP '05 will be held during May 15-18, 2005 in Seoul, Korea.

ICAPP provides a forum for the industry to exchange the latest ideas and research findings on nuclear plants from all perspectives. This Congress builds on the success of last year's meeting held in Córdoba, Spain and on that of the 2002 inaugural meeting held in Hollywood, FL. Because of the hard work of many volunteers from around the world, ICAPP '04 has been successful in achieving its goal. More than 350 invited and contributed papers or presentations are part of this Congress. There are 5 invited plenary sessions and 70 technical sessions with contributed papers. The ICAPP '04 Proceedings will contain nearly 300 papers prepared by authors from 25 countries covering topics related to advances in nuclear power plant technology. The range of topics covered includes the following: water cooled reactors, high temperature reactors, long term programs, plant reliability, safety assessments, thermal hydraulics, fuel and core design, materials, sustainability and nuclear power applications in

# Utility Working Conference By Harold Stiles

August 8-11, be on Amelia Island for the UWC 2004!

The UWC continues its 11-year tradition of being the best ANS conference for sharing utility innovations.

As General Chair for UWC 2004, **David Christian**, Senior VP and CNO, Dominion Generation, chose the very timely theme, "PROMOTING THE NUCLEAR SAFETY CULTURE: Realizing Operational and Economic Gains." Joining him in the opening plenary to communicate this message, are **Samuel Collins**, Regional Administrator, NRC Region I; **George Felgate**, VP and CNO, INPO; **David Modeen**, VP and CNO, EPRI; and **Robert Rubin**, Senior Investment Grade Credit Analyst, Deutsche Bank.

One innovation for UWC 2004 is the General Chair's Special Session on "Operating Under the New Security Requirements." The invited speakers for this session include **Christopher Crane**, Nuclear President and CNO, Exelon; **Barnie Beasley**, VP, Southern Nuclear Operating Co; **James Levine**, Executive VP and CNO, APS; and **John McGaha**, President, Entergy Nuclear South.

Another innovation for UWC 2004 is the re-organization of the meeting Tracks to better align with industry business models. During the 2 \_ day conference, attendees can choose from presentations in Configuration Management, Equipment Reliability, Operations, Work Management, Regulatory Relations, Nuclear Asset Management, Performance Improvement, and Material & Services. This Track alignment invites greater participation with the respective Communities of Practice in the industry. The conference also promotes improved communication by aligning, during each breakout period, four of the eight Tracks in two cross-functional sessions. Examples follow:

- Equipment Reliability and Materials & Services are co-organizing a session on "Equipment Obsolescence"
- Performance Improvement and Operations are coorganizing a session on "Organizational Learning from Operating Experience"
- Work Management and Nuclear Asset Management are co-organizing a session on "Work Management's Role in Nuclear Asset Management"
- Regulatory Relations and Configuration Management are co-organizing a session on "Managing the Process for Licensing New Nuclear Plants"

Again this year, the technology exhibit highlights innovative products and services from some of the leading vendors in the industry.

Finally, there are several industry meetings immediately following the conference. These include a workshop on Root Cause Analysis for Safety Culture and Human Performance Improvement, a NAM Fleet Management Sub-committee meeting, and the National Regional Utilities Group (RUG) meeting with the NRC. # Treasurer's Report By Greg Gibson

The year 2003 was good financially for the Operations & Power Division. We remained solvent, and we were able to position ourselves to complete our scholarship funding goals in 2004.

We started the year with \$56,877 in the bank, and we acquired \$20,911 in income for a total \$77,788. We spent \$10,000 in scholarships, \$6,500 in student support, and \$3,594 in expenses



(publications, awards, meeting costs) for an expended total of \$20,094. Therefore, we ended 2003 with a total of \$57,694. We anticipate increased income in 2004 from our sponsorship of the ICCAP, with an estimated total income of about \$36,000 by the end of 2004.

The OPD Executive Committee budgeted three main items for 2004: (1) A one-time \$17,957 contribution was made to the three scholarship funds: Power Division [\$2000 annual scholarship], Bisesti [\$1000 annual scholarship] and Lacy [\$1000 annual scholarship]. This contribution increases the funds' principle amounts so that they can become perpetually "self-funded." (2) A \$2000 donation was made to the NEED scholarship. And (3) a \$6,000 contribution was made for student activities. The rest of the budget accounts for \$3500 in expenses (publications, awards, meeting costs). The total budget for 2004 is therefore \$29,457.

While our balance at the end of 2004 is estimated to be around \$64,000, we recognize that future income for the Division from meetings such as the Utility Working Conference, ICAPP, and the National ANS meetings

cannot be guaranteed. Accordingly, caution and prudence are the watchwords for the next year.
